## A Family-Friendly Weekly Update

According to the governor's mandate, anyone attending any activity inside a school district facility must wear a mask. All activities include those attending meetings (School Board Meetings, booster group meetings, etc.), events, and performances. In addition, all visitors to the buildings must wear masks to enter.

☑ The Allegheny Valley School District's Health and Safety Plan, approved in August, remains in place. Students will see no change in the expectation that masks are to be worn in the buildings and on District transportation. Per the CDC, Allegheny County remains at a high transmission level. The District will continue to monitor information and direction from the Department of Education, the Pennsylvania Department of Health, and the Center for Disease Control, in addition to cases and conditions within the School District. Additional guidance will be provided as more details are announced.

The Allegheny Valley School District will be hosting a COVID 19 Vaccination Clinic in partnership with UPMC for children ages 5-11. Vaccinations and boosters for individuals 12 + will also be available at that time. The Pfizer Vaccine will be offered to all eligible students (age 5 and older), family members, staff, and the community. Please complete the form at xxx if you are interested in this opportunity. Pending the results of the interest survey, UPMC will schedule an evening date and time. Children under the age of 12 must be accompanied by a parent/guardian.

## **COVID-19 Information:**

## Allegheny Valley School District 16th Annual Holiday Card Art Contest November 2021

The Allegheny Valley School District will sponsor a contest for artwork to be used for the District's Holiday Cards. The following rules apply:

- 1. Any student in pre-Kindergarten through grade 12 is welcome to enter the contest.
- 2. All artwork must be of original design and depict some holiday event, happening, or activity.
- 3. Artwork can be completed freehand or on the computer; however, the design must be able to be set up in an electronic format.
- 4. Entries must be of original work. If using other (stock) photos, the photo must be manipulated in such a way as to make it apparent as the student's own work. Designs may be researched for originality. Any design that shows significant resemblance to the original artwork will be disqualified.
- 5. Artwork will be used for the District's Holiday Cards and possibly other publicity items that the District deems appropriate.
- 6. Four prize winners will be selected as noted:
  - a. (1) winner from pre-Kindergarten through grade 3
  - b. (1) winner from grades 4-6
  - c. (2) winners from the Springdale Jr-Sr High School ((1) from grades 7, 8, & 9 and (1) from grades 10, 11, & 12)
- 7. A \$50.00 prize will be awarded to all winners.
- 8. If no winner is selected from one of the groups above, a second entry from elementary or secondary will be selected.
- 9. A completed entry form must be attached to the back of the entry.
- 10. No names of the artists may appear on the front of the artwork.
- 11. All entries must be submitted by December 3, 2021 to the art teacher in the elementary buildings and the main office at the high school.
- 12. The decision of the judges is final.
- 13. All designs become the property of the Allegheny Valley School District. No royalties or other awards will be paid to any entrant.
